## **Product Information**

Sublimation resistant, printable Polyurethane vinyl (white) with a blockout interlayer. Suitable for bright and dark textiles.

TURBO PRINT 4010-S BLOCKOUT is compatible with all current printers using ECO-solvent, solvent and latex inks. The self-adhesive PET film liner allows even filigree motifs to be cut by all current CAD/CAM plotters after printing. To avoid a sublimationmigration we recommend that the garment is not preheated.

The vinyl possesses a soft textile touch and has excellent cutting and weeding attributes. After the thermal transfer, a semi-matt finish with high resolution is achieved.

After heat-transfer we recommend removing the PET-liner warm. We recommend POLI-TACK 854 or POLI-TACK 853 for the application process.

TURBO PRINT 4010-S BLOCKOUT is suitable for transfer to textiles like cotton, polyester, uncoated nylon, mixtures of polyester/cotton and polyester/acrylic. For application to Nylon that is treated with any kind of coating, please test for suitability. The transfer vinyl is used for motifs and logos on sport, leisure and work wear.

## We recommend evaluation on test material.

Due to the various influences which occur from production and transfer of plotter letterings, consistency of the carrier materials and also washing and cleaning conditions, product liability can only cover the unprocessed material.
